Thank you for your interest in speaking at the 2026 Integrative Dermatology Symposium (IDS) hosted by LearnSkin. Please review the following information carefully. All submissions are due **Wednesday, December 5, 2025.**

NO LATE SUBMISSIONS WILL BE ACCEPTED.

Offerings must be clinically relevant and should provide attendees with information that can be applied immediately.

Submission Instructions

All proposals must be submitted through the online collection portal. You will be required to fill out an information form and upload a full abstract document and speaker photo. There is also space for you to upload additional documents if desired, and to include links to any online samples or documentation.

Proposals submitted by **December 5, 2025**, will be reviewed by the IDS Steering Committee, who will make selections based on content, objectives, relevance, significance, originality, clarity, and speaker experience. All persons who submit proposals will receive notification of the committee's decision no later than **January 23, 2026**.

Presentation Format

To maximize clinical worthiness, presentations should, whenever possible, include cases, detailed treatment information, and minimal basic information (i.e. anatomy & physiology).

The majority of conference presentations will be in 20-minute sessions. Please prepare a topic in which you are able to cover the material in that amount of time.

If you are not selected as a speaker, you may also have the opportunity to present at one of our poster sessions. Poster sessions provide an opportunity to present your research and patient outcomes.

Commercial Bias

Presentations must be free from real or perceived commercial bias and appropriate for continuing medical education credits.



Presentation Requirements

- Your presentation should be factual and report significant research findings, clinical procedures and results, techniques, or topics.
- All presentations (final PowerPoint slides/handouts) will be reviewed by the IDS Steering Committee.
- Presenters are responsible for their own expenses, including travel and any other costs incurred by conference participation. We will provide an honorarium and hotel accommodations.
- The IDS Steering Committee reserves the right to suggest edits, co-presenters, and to combine submissions.
- Speakers must be available to present during any day of the conference, August 20-23, 2026, as sessions cannot be scheduled per individual requests. IDS 2026 will be hosted at Grand Hyatt Indian Wells in Indian Wells, CA.
- All speakers must provide information on any real or potential conflicts of interest and disclose any affiliations or financial interests to the session attendees.

- **Headshot**, please provide a high-resolution photograph
